# Free School Meals - are you eligible to apply?

Please consider applying for your child to get free school meals should any of the following apply to your family. Not only will they receive a daily free school meal, they will bring in additional funding that is targeted towards key resources and provision to support the learning journey. For every pupil registered as eligible, the school will receive additional funding in the school budget called: Pupil Premium (£1,480 per child) which is used to help raise achievement levels.







# Children can get free school meals, if their parents or guardians get:

- Universal Credit your net earned income must be less than £7,400.
- Income Support.
- Job Seeker's Allowance (income based).
- Employment and Support Allowance.
- Child Tax Credit. (With an annual income of less than £16,190. As assessed by Her Majesty's Revenue and Customs.)
- Guarantee Credit element of Pension Credit.
- Support payments under Part VI of the Immigration and Asylum Act 1999.
- Working Tax Credit Run-on (paid for 4 weeks after you stop qualifying for Working Tax Credit).
- If you get Working Tax Credit, your child(ren) are not entitled to free school meals.

## To apply:

- Simply click on the Calderdale Council logo (below) and complete the form.
- Or, call in to the school office for a paper copy, complete and return it to our administration team who will submit it for you.

# Don't all children in Reception, Year 1 and Year 2 get free school meals anyway?

Yes, all children who are in these classes do receive a Universal Free School Meal; however, if you think you meet the criteria above, we respectfully encourage parents of children who receive UFSM to still apply for free school meals (if the above criteria is met) as this will ensure school receives essential funding for your child.
